If you are objecting to the request, please complete this form within ten (10) business days after receipt of the Request to Stop the Income Withholding Order and return it along with the Request to Stop Income Withholding Order and any supporting documentation to:

Upon review of your objection to the Request to Stop the Income Withholding Order and all supporting documentation, the IV-D Agency will make a determination within 45 days of the date the request was received. You will be notified of the determination in writing and an appropriate order will be entered based on the determination.
