Support Recipient Enforcement Review Letter

The Division of Child Support Services (DCSS) is reviewing your case.

When a support payor is not paying their court-ordered child support in full and on time each month, actions can be taken prior to filing a court action. The following actions have been taken in efforts to collect the court ordered child support:

1. Issued an income withholding order to NONCUSTODIAL ATLAS TEST's employer to take child support out of NONCUSTODIAL ATLAS TEST's paycheck;
2. Issued a one time income withholding order if NONCUSTODIAL ATLAS TEST received a lump sum payment such as a personal injury settlement, insurance claim, inheritance or lottery winnings so money can be taken from the payment to pay child support;
3. Reported the past due support balance to a consumer credit reporting agency which could impact NONCUSTODIAL ATLAS TEST's ability to obtain credit;
4. Seized federal and/or state income tax refunds or other federal payments;
5. Placed a lien on any real or personal property in NONCUSTODIAL ATLAS TEST's name such as real estate, motor vehicles and bank accounts;
6. Increased the payments on arrears;
7. Sent a notice of the support debt to the U.S. Secretary of State which could affect NONCUSTODIAL ATLAS TEST's ability to get or renew a passport.

We would like to update information on this case. Please contact your case worker NOHEMI A-000009923 at (623) 925-5255 to arrange a telephone interview so you can provide the information needed by the DCSS to review your case. If you are concerned with your safety for cooperating with the DCSS, please let your case manager know.



Enclosed are two forms to help the DCSS determine the best course of action available to enforce your child support order. If you received any payments directly from the other parent, please sign the Affidavit of Direct Support Payments. You can have the Affidavit notarized at the DCSS office free of charge. If you have not received any payments directly from the other parent, then complete and return the Judicial Enforcement Review only. Please return the forms to the DCSS by mail, email, or in person within ten (10) business days. Failure to respond may ultimately result in your case being closed or could prevent the DCSS from requesting a court hearing to enforce your order. If you are aware of any reason why the DCSS should not pursue a contempt action against NONCUSTODIAL ATLAS TEST, please let us know.

If the action taken on your case involves an enforcement hearing, the DCSS encourages you to come to court for the initial hearing so you have an opportunity to inform the court about the impact on your family as a result of not receiving court-ordered child support.

If you are receiving Temporary Assistance for Needy Families (TANF) cash assistance and the requested information is not returned to us within ten (10) business days, we will notify your eligibility worker that you have not complied and this will affect your grant.
