Advance Notice of Termination of Current Child Support Enforcement

Our records show that CHILD TEST will turn 18 on 4/15/2028. According to state law, the obligation for current child support ends when a child reaches the age of majority (18). If a child is attending high school or a certified high school equivalency program when he/she reaches the age of 18, current child support shall continue to be provided while the child is actually attending high school or the equivalency program but only until the child reaches nineteen years of age, unless the court enters an order pursuant to A.R.S. § 25-320 for a mentally or physically disabled child.

We will stop enforcing and collecting current support for your child unless we receive the required information by 3/16/2028. All unpaid arrears payments for past due support will continue to be collected.

If CHILD TEST is attending high school or a certified high school equivalency program, please complete the **STATEMENT REGARDING SCHOOL ATTENDANCE** form and take it to the school for a school official to certify the information you provide.

IF WE DO NOT RECEIVE THE STATEMENT REGARDING SCHOOL ATTENDANCE, CURRENT CHILD SUPPORT ENFORCEMENT AND COLLECTION WILL BE STOPPED.
