Passport Payment Agreement

I, NONCUSTODIAL ATLAS TEST the obligor in the above case(s), acknowledge owing child support arrears and interest in the above referenced case number(s) in the amount of \$25,000.00 as of October 16, 2024, As a result of the arrearages accumulated on the above mentioned case(s), the Division of Child Support Services (DCSS) has submitted this/these case(s) to the Federal Passport Denial Program as part of its administrative enforcement remedies.

I NONCUSTODIAL ATLAS TEST understand that the DCSS has initiated this administrative enforcement action and am requesting that the hold on my passport be released.

In exchange for the passport hold release by DCSS, I NONCUSTODIAL ATLAS TEST understand and agree to the following payment plan.

NONCUSTODIAL ATLAS TEST agrees to pay a lump sum payment in the amount of \$10,000.00 to be paid on or before 11/01/2024.

NONCUSTODIAL ATLAS TEST agrees to pay the remaining arrears in two payments of \$5,000.00. The first payment of \$5,000.00 will be due on or before 11/08/2024. The second payment of \$5,000.00 will be due on or before 12/06/2024.

The DCSS agrees that it will notify the Federal Office of Child Support Enforcement (OCSE) to release the passport hold immediately upon receiving the initial lump sum payment of \$5,000.00 and the signed agreement.

NONCUSTODIAL ATLAS TEST shall make these payments by personal check, cashier's check, money order, or credit card. If by check or money order, payments shall be made through and payable to the Arizona Support Payment Clearinghouse and shall include the AZCARES case number 001428730400. The payment shall be mailed to:

NONCUSTODIAL ATLAS TEST understands that in the event of a failure to pay as required by the agreement, the agreement shall be terminated. NONCUSTODIAL ATLAS TEST will owe the entire amount of the arrears less any payments which have been received and credited to the case, DCSS may issue a Notice to Revoke Passport to the Federal Office of Child Support (OCSE) without further notice, and the automated enforcement remedy of Passport Denial shall be reinstated.

NONCUSTODIAL ATLAS TEST understands that this agreement in no way affects the \$500.00 due monthly.

NONCUSTODIAL ATLAS TEST understands that the DCSS will not notify OCSE to release the passport hold until this payment agreement is signed by all parties, received by the DCSS and the initial payment of \$5,000.00 has been received and cleared the bank. NONCUSTODIAL ATLAS TEST understands that the process to reinstate the passport may take 7-10 business days. A payment which is returned for insufficient funds shall invalidate this agreement.

NONCUSTODIAL ATLAS TEST understands that this agreement in no way affects the \$500.00 due monthly.

By signing this document, each party indicates that they have read the agreement, fully understand the terms, and have entered into the agreement freely and voluntarily.
